# **March Meeting Minutes**

Meeting Open Time: 7:00 PM at the Brookline American Legion Hall and via Zoom. 8 members were present and one guest, Captain Mary Riddle (USAFR).

Minutes: A motion was made by Chris Lussier to dispense with the verbal reading of the Minutes since they were published in the newsletter; seconded by Bruce Moran and unanimously approved.

Quartermaster's Report: The Quartermaster's Report was read. The Post received an EFT of \$3.50 from National and \$10.50 from dues, for a total \$16.09. There were three of disbursements: \$418.72 the Brookline to American Legion Post to pay for the VFW Post share of the heating oil expenses; \$1,000 donation to the Hollis-Brookline High School Debate Team; \$1, 858.31 for insulation and sheetrock shed. Andy Seremeth made a motion that the Quartermaster's report be accepted as read, pending audit; seconded by Bruce Moran, and unanimously approved.

## **Committee Reports:**

- Patriots' Pen presentation will be the last day of school. Certificates and gift cards need to be purchased. Chris Lussier made a motion that the Post purchase Amazon gift cards and certificates; seconded by Bruce Moran and unanimously approved.
- George Robinson stated our Post's scholarship is posted at the High School so students can apply.

**Membership:** Jim Kelly and John Kelly (not related) memberships are now current.

#### Comrade in Distress:

- Greg d'Arbonne thanked the Post for supporting his dad's funeral by providing military honors.
- Jim Belanger stated his daughter is diagnosed with ALS. The Post members all expressed their condolences and support to Jim, his daughter, and their entire family at this difficult time.
- Chris Lussier stated Bob Smith went to the hospital with pneumonia and was discharged three days later. Bob then got a severe ear infection and went to the hospital in

Portsmouth. With antibiotics his infection started to clear but he had balance problems. Bob is now in Crestwood Rehab Center in Milford. Bob will leave there once his wife and daughter are clear of the COVID they both have at the moment.. Chris and Mark Andrews brought Bob's recliner from his home so he could sleep sitting up since laying down caused pain. Hopefully, Bob will be home soon.

#### **Old Business:**
