April 20th Meeting Minutes

Meeting Open Time: 7:00 PM at the Brookline total of \$1,899.50. Bruce Moran made a motion American Legion Hall and via Zoom. 10 members were present.

A motion was made by Chris Lussier for authorization to pay for the items in full with the expectation of full reimbursement by the Town, seconded by Bruce Moran and unanimously approved.
- Greg d'Arbonne will order the 4 wreaths for the Memorial Day event. The Town will reimburse the Post.
- Tony Fowler is the guest speaker for the event.
- Chris Lussier will make the request students from the HBHS to read the names of the Veterans.
- Chris ordered more durable flags that can be placed at the Beth Abraham Cemetery as the
